**1) Sylwadau Agoriadol/Opening Remarks:**

The Council stood and observed a period in silence and with reverence in memory of Marcia Williams who died suddenly.

**4) Cofnodion/Minutes:**

**5 & 6) Materion I'w Trafod/Matters for Discussion:**

- 1) Traffic a Parcio – Dim symudiad ar y mater o drosglwyddo darn o dir tu ol i Neuadd yr Eglwys ar gyfer creu maes parcio. Dim ymateb gan yr Eglwys hyd yn hyn.
- 2) Cyfyngu amser parcio ar Stryd Bangor – Adroddwyd bod Cyngor Gwynedd yn gweithredu ar hyn gyda'r bwriad o newid y cyfyngiadau o Maes Elim draw heibio'r Felin Sgwrsio, i ddwy awr a dim cyfyngiad ar y penwythnos. Bydd cyfyngiad presennol yn aros ar bob rhan arall o Stryd Bangor.

- 3) Siwrne Saff: adroddwyd y bydd y gwasanaeth yma yn y pentref mor aml a phosib.
- 4) Y Gornel ger Gardd Fon: adroddwyd bod Cyngor Gwynedd wedi gwneud cynllun a bydd y mater yn cael ei drafod ymhellach yn y cyfarfod nesaf.
- 5) Prydlesu 3 medr o dir hen drac y Rheilffordd ger Ffordd Caernarfon ; Adroddwyd bod Cyfreithiwr Y Cyngor wedi cael golwg ar y llythyr dderbyniwyd oddi wrth Cyngor Gwynedd ac yn fodlon gweithredu ar ran y Cyngor. Penderfynwyd penodi Mr Gerallt Jones, LL.B. o gwmi Emyr Thomas a'i Fab, i weithredu ar ran y Cyngor ac i'r Clerc hysbysu Cyngor Gwynedd o'r penderfyniad i fwrw mlaen a'r Brydles ac i gysylltu a Mr Gerallt Jones fel eu cyfreithiwr.

Felin Daclus :-

- 1) Adroddwyd bod y Cadeirydd a Chynghorwyr Carolyn Pritchard a Daniel Williams wedi bod yn clirio darn o dir ger arosfan bws wrth yr Eglwys a bod Cyngor Gwynedd wedi gosod bun newydd yno.
- 2) Llwybr preifat rhwng Uwch Menai/Penceunant/Stryd Menai. Penderfynwyd, fel arwydd o ewyllys da, i ofyn am bris gan y contractwr sydd yn gofalu am y fynwent a'r llwybrau i lanhau a thacluso'r llwybr yma er mai llwybr preifat i'w hi. Clerc i gysylltu a'r contractwr ac i symud ymlaen os yw'r pris yn rhesymol.
- 3) Adroddwyd bod y Felin Daclus wedi plannu coed ar y tir y tu ol i'r maes parcio cymunedol. Clerc i hysbysu Arfon Jones Contractwrs, rhag iddynt dorri'r coed pan yn tacluso'r rhan yma o'r llwybr.

Canolfan Iechyd Rowen : Pethau yn symud mlaen.

Tai Fforddiadwy : Gweler cais cynllunio.

Traffic and Parking -

- 1) Reported that there was no progress to report on the transfer of a parcel of land at the rear of Church Hall for the purpose of creating a parking area.. No response from the Church at this stage.
- 2) Parking restrictions on Bangor Street - reported that Gwynedd Council are working on this with the intention of amending the restrictions from Maes Elim to beyond Felin Sgwrsio, to two hours with no weekend restrictions. The current restrictions will remain in place for the remainder of Bangor Street.
- 3) Arrive Alive: Reported that this service will be in the village as often as possible.
- 4) Gardd Fon Corner: Reported that Gwynedd Council have prepared a scheme and the matter will be discussed at the next meeting.
- 5) Lease of 3 metres of the old railway line land near Caernarfon Road: reported that the Council's Solicitor had studied the contents of the letter received from Gwynedd Council and was prepared to act on behalf of the Council. It was agreed that Mr Gerallt Jones LLB, Emyr Thomas & Son, be appointed to represent the

Community Council and for the Clerk to notify Gwynedd Council of the appointment; the decision to proceed with the Lease, and to consult with Mr Gerallt Jones as their solicitor.

FELIN DACLUS -

1. Reported that the Chairman and Councillors Carolyn Pritchard and Daniel Williams had been clearing a parcel of land near the bus stop by the Church and that Gwynedd Council have sited a new rubbish bin there.
2. Private footpath between Uwch Menai/Penceunant, Menai Street. Decided as a gesture of good will, to ask the Contractor that is undertaking work at the cemetery and footpaths for a price to clear and tidy up this footpath despite it being a private footpath. Clerk to consult with the contractor and to proceed if the price quoted is reasonable.
3. Reported that a quantity of saplings had been planted on land at the rear of the community car park. Clerk to notify Arfon Jones Contractors, in case they break the saplings when tidying up this part of the footpath.

Rowen Health Centre : Matters are proceeding.

7) Adroddiad Pwyllgor Rheoli'r Neuadd

Adroddwyd fod ymgynghoriad cyhoeddus wedi ei gynnal a bod yr ymateb yn ffafriol i'r datblygiad. Cafwyd ambell i syniad nad oedd wedi ei ystyried o'r blaen. Un o'r rhain oedd creu grisiau i gysylltu'r ystafell bwyllgor a'r neuadd. Penderfynwyd cynnwys yr awgrymiad yma yn y cynllun ac i Alun Meirion, y Pensaer weithredu ar hyn.

Adolygiad Cyflog y Gofalwr – Adroddodd y Clerc bod y Gofalwr yn awyddus i dynnu'r llythyr yn gofyn am adolygiad cyflog yn ôl. Derbyniwyd y cais. Eglurwyd y bydd rhaid edrych yn fanwl ar gytuned cyflogaeth y gofalwr unwaith bydd gwaith addasu'r neuadd wedi ei gwblhau. Bydd angen cytundeb cyflogaeth ysgrifenedig yn ogystal a rhestr dyletswyddau newydd. Penderfynwyd gadael popeth fel y maent nes bydd newidiadau yn y Neuadd wedi eu cwblhau

Materion cynnal a chadw. Yn dilyn y dywydd arw yn ddiweddar, roedd gwlybanaeth wedi ymddangos ar rhan o lawr y Neuadd. Clerc i gysylltu a Mr Albert Williams

HALL MANAGEMENT COMMITTEE - reported that a public consultation had taken place and that the response to the development had been favourable. A few suggestions, that had not been previously considered, were received. One of these was to create stair access between the Hall and the Community Room. This suggestion was well received and it was agreed to include this suggestion within the plans and for Alun Meirion, the Architect, to amend the plan.

Caretakers' Salary – The Clerk reported that the caretaker wanted to withdraw her letter requesting a review of her salary. The request was accepted. It was explained that it would be necessary to look very carefully at the caretakers' contract of employment once the development at the Hall had been completed. There will be a need for a written contract of employment as well as a new list of caretakers' duties and responsibilities. AGREED to leave matters as they are until the alterations at the Memorial Hall are completed.

Matters of repair and maintenance – Following severe weather conditions, water had penetrated through the roof onto part of the Hall floor.  
Clerk to consult with Mr Albert Williams.

- 4) Hilbre, Lon Llwyn, Y Felinheli – cais cynllunio i newid defnydd o dy i dy a Meithrinfa – trafodwyd y cais yma mewn pwyllgor blaenorol gyda chanlyniad i wrthwynebu'r cais am amryw o resymau. Yn dilyn hyn, derbyniwyd lythyr oddi wrth yr ymgeisydd, drwy law swyddog cynllunio Cyngor Gwynedd, yn ymateb rhan helaeth o'r rhesymau a nodwyd. Ar ol trafodaeth estyngedig, methodd y Cyngor a dod i benderfyniad. Penderfynwyd bod angen ymweliad lleoliad a chytunodd Cyng Ken Brown; Lena Ashley; Pat Jones a Pat White gyfarfod am 2.0pm pñawn Llun, 14eg Tachwedd ac i'r Clerc drefnu presenoldeb Mr Idwal Williams, Uwch Swyddog Cynllunio Cyngor Gwynedd i fod yn bresennol os yn bosib.

Hilbre, Bush Road, Y Felinheli – planning application for change of use from dwelling into a dwelling and nursery accommodation – this matter had been discussed at a previous meeting when it was decided to object to the application for a number of reasons. Following this, a letter was received from the applicant forwarded by the Planning Officer, Gwynedd Council, responding to most of the objections raised. After an extensive discussion, the Council failed to agree on a decision. Decided that a site visit would benefit and it was agreed that Cllrs Ken Brown, Lena Ashley, Pat Jones and Pat White would meet at 2.0pm on Monday, 14<sup>th</sup> November and for the Clerk to arrange for Mr Idwal Williams, Senior Planning Officer, Gwynedd Council to be present if at all possible.

Adroddwyd hefyd bod gor dyfiant yn gorchuddio clogfeini llechan ar Lon Las. Y Clerc i gysylltu a Mark Balaam, Cyngor Gwynedd

Reported that one of the bollards recently installed in the car park had been damaged to such an extent that it could not be used and there was a need for a new one. DECIDED not to replace the bollard.

Reported also that overgrowth had completely covered the slate boulders on Lon Las. The Clerk to contact Mark Balaam, Gwynedd Council.

Arolwg Llwybrau : cafwyd ymateb gan Adran Llwybrau, Cyngor Gwynedd yn dilyn ymholiad gan y Cyngor Cymuned ynghlyn ar arolwg gwblhawyd ganddynt. Cadarnhawyd bod yna waith o lanhau/tacluso yn cael ei weithredu gan gangiau cymunedol ar lwybrau cyhoeddus rhifau 16 –17 – 18 a rhan o stepiau o Ffordd Caernarfon i Gei Llechi. Mae arwyddion wedi eu gosod ar lwybr cyhoeddus rhif 21 – un wedi ei osod ar byst arwydd Ffordd Caernarfon gyferbyn a rhif 1 Penceunant ac arwydd golofn golau stryd gyferbyn a Clwb y Felin. Bydd gwaith i gau tyllau/hwyneb anwastad yn cael ei weithredu ar ran o lwybr cyhoeddus rhif 21 tu cefn i stryd Penceunant.

Cysgodfan – Bu i'r Clerc gadarnhau ei fod wedi gwneud cais am gysgodfan yn y Wern, dros ffordd a'r ysgol.

Footpaths – a response had been received from the Footpaths Department, Gwynedd Council, following an enquiry from the Community Council regarding the survey completed by them. It was confirmed that cleaning and tidying up work is being undertaken by the Community Gang on footpaths Nos 16-17-18 and part of the steps leading from Caernarfon Road to Cei Llechi. A sign has been placed on public footpath No 21 – one on road sign post Caernarfon Road opposite No 1 Penceunant and one on a street lighting lamp opposite Clwb y Felin. Work filling holes and uneven surfaces is being undertaken on part of public footpath No 21 at the rear of Penceunant.

Bus Shelter – The Clerk confirmed that he had submitted an application for a bus shelter at Y Wern, opposite the school.
