- 1) Application to create a mussel fishery on the sandbank opposite Felinheli between Castell Gwylan and Moel y Don. Many are concerned about the possible effect on fishermen, sailors and walkers. The consultative period has ended and unfortunately, the local community was not aware of it until very late in the day. However, I am in discussion with the company and they have agreed to come to Felin to explain what they have in mind. I hope this can happen early in the New Year. They will be meeting the Sailing Club next week. I am in favour of developing the local seafood industry but we need to protect the interests of local people.
- 2) Path near the Afon Heulyn: the footpath has been closed following the collapse of part of the Faenol wall. Thanks to the Chair of the Community Council for his prompt action. I have asked for a report from the footpaths officer on the steps that will be taken to ensure the path can be reopened. Quay steps remain closed but he Council has agreed to build a buttress to safeguard the wall.
- 3) Sea Wall: After being contacted by an elector, I asked Gwynedd Council officers to investigate the condition of the sea wall. I had a report back from the maritime officer saying that the situation does not cause great concern and from the Coastal Defence Unit saying they will continue to monitor the wall.
- 4) Rhyd Y Fenai: I helped electors who were worried that the new hand rails would prevent them from accessing their gardens and clothes lines. We reached agreement with CCG and the rails are now in place. I am now asking for more work to de done including repairs to the steps, new surface and safety measures on the balconies.
- 5) Recycling: The Council has moved to the new arrangements of collecting recycling material/food waste every week and residual waste form the green bins every 3 weeks. There haven't been many problems with this. The new Cartgylchu has been distributed to appropriate homes. The Council does not think that Stryd Menai and Stryd Bangor are suitable but individuals here or in other parts of the village that have not been supplied with a cart can apply for one. - 6) Rowen Path: Cyngor Gwynedd has confirmed that land-owners have agreed to the intention to improve the footpath before it's officially adopted as a public footpath by the Council. I understand that the work will commence early in 2016.
- 7) Coastal Path: the scheme is moving along with the legal work of obtaining permission from the different land owners. We will all be glad to see the path opening officially before next summer hopefully.
- 8) National Grid the consultation on bringing pylons to Pentir over the land in the vicinity of Faenol/Nant y Garth/Treborth closes on Dec 16. I am arguing for undersea cables from Anglesey to Deeside. <a href="http://www.cysylltiadgogleddcymru.com/">http://www.cysylltiadgogleddcymru.com/</a>
- 9) With the support of the Plaid Cymru Councillors' Group I submitted a proposal on CUTS that was discussed by Cyngor Gwynedd On Dec 10. It was passed unopposed by Gwynedd Council.
