1. Dim problemau wedi ei chofnodi ynglŷn â'r llwybrau, meinciau na cysgofannau.
 2. Bydd archwiliad llwybrau'r pentref yn cael ei gwblhau yn wythnos olau Mis Gorffennaf. Os oes rhywun a diddordeb i helpu yna cysylltwch â fi neu Siân ar gyfer cael llwybr neu lwybrau.
 3. Gwelliannau Llwybr Garddfon yn disgwyl cymeradwyaeth. Er hynny gall y Clerc anfon at Gyngor Gwynedd gydag ymholiad.
 4. Mae ymholiad wedi ei wneud gan Gymdeithas y Ramblers ynglŷn a'r diffyg mynedfa, camfeydd ar arwyddion i lwybrau 19 a 20 y Felinheli drwy Lanfair-is-gaer. Mae hyn wedi ei godi eisoes tua 3 mlynedd yn ôl ac roedd gan y Cyngor Cymuned ac roedd cynnydd ar y mater yn ddibynnol ar drafodaethau ynglŷn â llwybr newydd ar hyd yr arfordir, nid oes unrhyw ddatblygiad. Efallai bydd hyn yn ysgogiad.
 5. Diwrnod Gwaith Llwybrau wedi ei gynnal ar y 27ain o Fehefin rhwng y Gymdeithas Ramblers a Cyngor Gwynedd ar Lwybr 113 Llanddeiniolen ger Gelli Gyffwrdd gyda chaniatad y ffarmwr. Mae'r llwybr yma yn bwysig syn galluogi cyswllt drwy ganiatáu teithiau cerdded o'r Felinheli. Cafodd gryn dipyn o lystyfiant ei glirio. Bydd ail ddiwrnod yn cael ei gynnal yn fuan i drwsio giât fochyn a chodi arwyddbyst ac arwyddion. Gobeithir cynnal ddiwrnodiau waith ar y trydydd dydd Mercher o bob mis gyda seibiant yn Mis Awst.
 6. Mae taflen Gareth Roberts ar gyfer Llanddeiniolen wedi ei gymeradwy gan lawer o gerddwyr a gobeithiaf gellir sicrhau adnoddau ar gyfer taflen o'i math ar gyfer Y Felinheli. Dylai ystyried sut gellir sicrhau adnoddau ar gyfer newidiadau ac ail gyhoeddi, sut i'w ddsbarthu a'i roi ar y we.
1. There have been no new reports of problems with paths, benches or shelters.
 2. The village path survey will take place during the last week of July. If anyone would be able to assist please contact Sian or me to get a path or paths.
 3. Footpath near Garddfon. Improvements are probably awaiting approval of the final route for the Wales Coastal Path. However, the clerk could make a written enquiry to Gwynedd CC.
 4. There has been an enquiry from a Ramblers Association member about the lack of access, stiles or signing for Felinheli footpaths 19 and 20, through Llanfair-is-gaer. This was raised by the Comm. Council about 3 years ago and progress seemed to be pending negotiations for a new path through Llanfair-is-gaer alongside the coast edge for the Wales Coastal Path, of which nothing has been heard. However, this new enquiry may spark some action.
 5. A Ramblers Association/ Gwynedd CC footpath work day was held on 27th June on Llanddeiniolen path 113, just beyond the Greenwood Centre, by agreement with the farmer. This path provides an important link allowing circular walks from Felinheli. A large amount of vegetation was cleared. A second day will be held soon to repair a kissing gate and install way marking posts and signs. It is the intention to hold work days on the third Wednesday of each month, except for a break in August.
 6. Gareth Roberts' leaflet for Llanddeiniolen has been highly praised by various walkers and so I hope funds can be found for a similar leaflet for Felinheli. It needs to be considered how it can be financed in the longer term for modifications and reprints and as to how it can be distributed or made available on the internet.
