1) Sylwadau Agoriadol/Opening Remarks:

Diolchodd y Cyng Ken Brown i'r Cyngor am y fraint o'i ethol i'r swydd o Gadeirydd. Eglurodd y buasai'n annodd i unrhyw berson gymeryd y cadeiryddiaeth ar ol cyfnod Sian Gwenllian yn y gadair gan addo y buasai yn gwneud ei orau oddimewn ei allu. Diolchodd i Sian am ei holl waith trylwyr yn ystod ei chyfnod fel Cadeirydd a chyhoeddodd balchder y Cyngor bod Sian yn parhau fel aelod o'r Cyngor.

Cllr Ken Brown thanked the Council for the honour of being elected to the post of Chairman. He explained that it would be difficult for any person to follow in Sian Gwenllian's footsteps but promised that he would do his best within his ability. He thanked Sian for all her sterling work during her period as Chairperson and declared the Council's appreciation that Sian will continue as a member of the Council.

 - ii) Traffic and Parking – New Parking Area at the rear of Church House – Following a meeting it was suggested that the Community Council proceed to secure a Lease of perhaps £5 per year for the land at the rear of Church House. It appears that the area will provide parking for about 20 vehicles. DECISION: Proceed with the Lease even though the Council does not have the funds at the present time to start the work.

 - v) Affordable Housing : Tan y Maes, Y Felinheli. Discussions on-going.
 - vi) Lease on the old Railway Line, Caernarfon Road – Letter received from Council's Solicitors requesting confirmation of the terms of the Lease. Cllr Iestyn Harris to consider and to respond through the Clerk
 - vii) A487 Caernarfon to Bontnewydd study – a simulation of the three routes shown prior to the Annual Meeting the opinion favouring the purple route as being the more advantageous to Y Felinheli
 - viii) Dog Fouling – suggested that bins be situated in Bangor Street, the corner of Tan y Maes as well as the other locations notified at the last meeting.

Reported that a verbal request had been made regarding the burial of ashes and a body in the same grave. Following a discussion it was decided that there would be no objection when the burial of ashes follows the burial of a body, but in a reverse situation, i.e. ashes first, that it is required that the ashes are buried in a grave for burial of a body at a depth of six feet.

Fees 2010–2011. Decided to increase the fees by £20 for local residents and £40 for others.

The footpaths will be upgraded and all the footpaths from the football field will be joined up.
